This Health Guarantee is understood & accepted by both Buyer & Seller of above stated puppy. No changes will be accepted outside what is stated in this contract, Buyer agrees to these terms.

Check only if applicable: The above stated puppy is being sold with the promise not to be breed due to the size of puppy. ***New Owners Initials:*** _____

- The puppy being purchased is guaranteed to be current on its 5-1 vaccine. Buyer understands that the puppy will need boosters of the initial vaccinations, generally spaced three weeks apart, until the 5-1 "puppy series" is completed, and then once annually thereafter. Seller is not responsible for any sickness/disease etc... due to a non-vaccinated puppy. Seller is not responsible for any reactions caused by vaccinations.
- Buyer is responsible to get a Health Exam within 48 hours from date of purchase of above said puppy by a licensed Veterinarian in good standing with the Veterinarian State Board A copy of this exam signed by a licensed veterinarian must be mailed to Seller and postmarked within 72hrs from date of purchase, or else Health Guarantee is null and void. ***New Owners Initials:*** _____
- At no time will a cash refund be given after a deposit or purchase has been made for said puppy. Only replacement puppy will be provided if it is covered within the terms of this contract
- All veterinarian expenses concurred during the life of the above said puppy is the buyer's responsibility, at no time will any veterinarian costs be the seller(s) responsibility. The seller is only responsible to replace a puppy of equal value if all terms are met in this contract.

- This guarantee applies only to the above said puppy with the above stated buyer and is nontransferable to a second party.
- The above said puppy is guaranteed until (1) one year of age against fatal and life altering congenital disease/defect which adversely affects the health of the animal. If the dog dies from a congenital disease/defect within this (1) one year time frame, the buyer will pay to have it autopsied to ascertain reason. Seller must be notified of the problem within 24hrs of the licensed veterinarian's determination and have (2) two written reports from two unassociated licensed veterinarians stating the same problem sent to Seller within (10) calendar days and Seller will provide a replacement puppy of equivalent value, as available. Buyer assumes shipping cost (if any) of replacement puppy to be sent. A puppy with a defect must be returned or euthanized with the Prior permission of the seller to qualify for a replacement puppy.
- A returned puppy must be returned to the seller in good condition (it must be evident the puppy was well-taken care of i.e. fed, bathed etc), other than the specified problem, at the buyer's expense. The owner will then qualify for a replacement puppy. Buyer is responsible for transportation costs to and from the seller on a replacement puppy.
- No replacement puppy will be given if the puppy has been bred, spayed, neutered, or euthanized without seller's prior written permission.
- Replacement puppy will be mutually agreed upon by both parties and will be of comparable quality. It is understood that the replacement puppy may not be from the exact same parents of original puppy.
- There are certain disorders that may be caused by environmental factors, for example: allergies, thyroid dysfunction, demodectic mange, and other autoimmune disorders that **are not covered** by this guarantee.
- Any physical problem which is or could be the result of injury **is not covered** under this guarantee, this includes; Luxating Patellas
- There is no guarantee or warranty that the Buyer will be able to show or breed the puppy regardless of show or breeding potentials.
- Buyer has read and understands the facts of hypoglycemia. Hypoglycemia is not covered under this guarantee; this is a common issue with small breed dogs and is a preventive problem if proper care is provided to puppy. **New Owners Initials:** _____

This puppy is being sold as a companion to be apart of your family. Buyer will provide the puppy with a safe, stable, and comfortable home, proper food, and veterinary care as needed. Buyer promises above said puppy will be kept as a house pet, not an "outside" dog.
